Designing Web Communication

Students engage in serious study and practice of the ways that people produce effective communication in web environments. They read about a variety of issues related to

communication on the web and other networked information technologies. Additionally, they practice information design skills that will enable them to produce effective web-based documents.

Technical Document Design & Editing

This course introduces English majors to the practice of designing, evaluating, and editing technical documentation. We read research on document and interface design and practice with actual design problems. The course is organized around the premise that texts are interfaces that afford and constrain interpretations and uses of information. Focus is on learning to apply different visual and verbal design strategies. Students will work individually and collaboratively to design a variety of online and print texts. Instruction on various stages of comprehensive and surface editing.

Online Information Design and Evaluation

In this course, students learn to plan, write, revise, implement, and test instructional content in an online environment. Students will explore the impact of various web-based information technologies on communication and learning by reading about and discussing issues related to human-computer interaction, user-centered design, online document design, and activity analysis. The course offers some tool-based instruction for designing information in the static and interactive modes of communication that are possible in online spaces. Students complete two projects: a video tutorial and an online portfolio.

Theory and Research in Professional Communication

Seminar course in which students become acquainted with current and foundational issues in the scholarly research and theory in the fields of professional and technical communication. The course is topical in its organization; however, it is also designed to help students become familiar with concepts they are likely to encounter both in the graduate program and in professional spheres (e.g., reader analysis, task analysis, visual communication, information architecture, technological mediation).

Usability Testing for Technical Communication

Advanced study of usability inspection, inquiry, and testing theories and practices related to instrumental and instructive texts (i.e., computer-related, legal, medical, pharmaceutical, financial, etc.). Students gain practical experience testing a variety of texts, using several testing methods, including completion of a substantial, lab-based usability test. Students examine and practice different kinds of usability tests on various communicative artifacts ranging from the "interface" on household appliances to technical documents like web sites, instructions, and non-instructional texts.

Verbal Data Analysis

A course in discourse analysis and case study research design. Students gain hands-on experience using techniques for analyzing verbal data that may be drawn from texts, interviews, focus groups, group interactions, online communication and other varieties of spoken and printed texts.

(Software: Excel, TAMS Analyzer, QDA software for PC)

Communication in Networked Society

Doctoral seminar on the theories, histories, and practices of networked communication. Emergence, development, acceptance, and dissipation of a variety of networks organized around information and communication technologies. Survey of network theory and methods for studying networks, networked communication practices, and their effects on issues such as identity, labor, organization, power, etc.
